Transfer Australian Superannuation to KiwiWRAP KiwiSaver Scheme

To transfer your Australian superannuation funds to the KiwiWRAP KiwiSaver Scheme, you must:

- Have an active KiwiWRAP KiwiSaver Scheme account
- Have permanently emigrated to New Zealand
- Transfer your entire Australian superannuation balance to your KiwiWRAP KiwiSaver Scheme account (partial transfers are not allowed)
- Be transferring from an Australian complying superannuation scheme regulated by APRA (we cannot accept funds from an Australian self-managed superannuation fund).

IMPORTANT

Things to keep in mind

It's important to note that once you've transferred your Australian superannuation to New Zealand, you may not be able to reverse the decision unless you decide to permanently move back to Australia. Your Australian superannuation funds do remain subject to some Australian rules – even after you transfer them.

- You cannot use your Australian superannuation funds to purchase a first home or use them to count towards eligibility for the KiwiSaver HomeStart grant.
- Your one-off transfer won't count as a KiwiSaver contribution towards that year's annual Government contribution (also known as a member tax credit).
- You can withdraw your Australian superannuation funds when you turn 60 and are retired (by the Australian definition of retired).
- If you permanently migrate to a country other than Australia or New Zealand, you cannot take your Australian superannuation funds with you.
- You cannot transfer any UK pension funds that are part of your Australian superannuation funds to the KiwiWRAP KiwiSaver Scheme, unless certain criteria have been met. Please contact us for details if you have UK pension funds as part of your Australian superannuation.
- Transferred Australian superannuation funds will not be able to be transferred to a third country (so, any country apart from Australia or New Zealand).
- Your Australian superannuation funds will be converted to New Zealand dollars when the funds are transferred to the KiwiWRAP KiwiSaver Scheme.
- It is important to review the tax implications when transferring your Australian superannuation funds. The tax rates applying to Australian superannuation funds and KiwiSaver funds may differ. In addition, tax on taxable income is charged at a flat rate of 28% within the KiwiWRAP KiwiSaver Scheme, regardless of your marginal tax rate or prescribed investor rate.

How do I transfer my Australian superannuation funds?

If you have decided that you want to make a transfer, contact your financial adviser with the name of the Australian superannuation scheme you wish to transfer from. You will need to satisfy all documentary requirements of the existing Australian superannuation provider.

Please note, any documents that require certification must be received within 90 days of the date of certification. All the required documentation will be sent to the relevant Australian superannuation scheme.

When the Australian superannuation scheme has transferred the funds to us, we will notify your financial adviser.
